EPR - What will it cost?

Extended Producer Responsibility (EPR) is the lead of the four principal environmental legislation interventions being enacted after an initial Department for Environment, Food & Rural Affairs (Defra) consultation in 2021.

The AVA has held many presentations regarding various new legislative proposals, however we understand that not all our members have been able to attend. To cater for those who have not made it, the AVA has produced a summary of the AVA environment committee, and the new proposed legislation that is being discussed. Items on that agenda are the Single Use Plastics Tax, Packaging and Packaging Recycling Notes (PRN) Reform, Mandatory Cup Takeback and Deposit Return Schemes. More detail can be found **HERE**

Scotland DRS scheme held back by 10 months!

Scottish government have recently announced that the proposed DRS scheme, originally scheduled to go live in August 2023, will be delayed by up to 10 months. Whilst any delay with any legislation is never ideal, these extra 10 months will allow vendors throughout Scotland more time to prepare for the DRS scheme, and make sure they have the sufficient processes in place for when it does go live.

Scottish First Minister Humza Yousaf said he wanted to 're-set' the Scottish government's relationship with business. He explained: "We will use that additional time to work with businesses, and Circularity Scotland, to address concerns with the scheme and ensure a successful launch next year."
